8. Annual fees @ Rs 500/- per annum for the year...1993-94, 94-95 (Total Rs. 1000.00) be also remitted at an early date.

10. The school will not sponsor candidates for Board's examination of any other school/Board which is not affiliated to the Board.
11. The school will create Reserve Fund as per the requirement of the Affiliation Bye-Laws/ rules of the Directorate of Education Delhi in the joint names
12. If within the above period the school Authority fails to satisfy the condition of the Affiliation Bye-laws, the provisional affiliation granted to it will automatically stand terminated.
